ELIGIBILITY REQUIREMENTS TO BE CONSIDERED FOR THIS POSITION

GENERAL REQUIREMENTS:

1. Not currently “Flagged from Favorable Personnel Actions” or under a “Bar to Reenlistment.”
2. Must be or be able to complete 25H MOSQ within 12 months of assignment.
3. Must be able to meet the required service obligation (minimum of 12 months from course completion).
4. A Soldier who has a remaining contractual service obligation due to an incentive contract for a specific MOS or UIC may apply for M-Day vacancies but will lose remaining incentive payments with the possibility of recoupment, as applicable.
5. Must not be currently stagnant on NCOES/PME. (to include DLC requirements).
6. Soldiers command removed or self-removed from promotion consideration are not eligible to apply.

MOS SPECIFIC REQUIREMENTS:

1. A physical demands rating of Moderate (Gold).
2. PULHES: 212221.
3. Normal color vision.
4. A minimum score of 102 in aptitude area EL and 105 in aptitude area ST in Armed Services Vocational Aptitude Battery (ASVAB) tests administered prior to 2 January 2002.
5. A minimum score of 100 in aptitude area EL and 102 in aptitude area ST on ASVAB tests administered on and after 2 January 2002.
6. A minimum OPAT score of Long Jump (LJ) -0120 cm, Seated Power Throw (PT) - 0350 cm, Strength Deadlift (SD) - 0120 lbs., and Interval Aerobic Run (IR) - 0036 shuttles in Physical Demand Category of “Moderate” (Gold).
7. Be able to work at heights up to 40 feet for extended periods.
8. Be able to work underground in low light conditions for extended periods.
9. Ability to read, comprehend and clearly enunciate English.
10. Ability to work for extended periods in a confined area.
11. A security clearance of SECRET.
12. A U.S. citizen.
13. Formal training (completion of the MOS 25H Course) conducted under the auspices of the US Army Signal School is mandatory or waiver may be granted by Commandant, U.S. Army Signal School, ATTN: ATSO-CD, Ft Eisenhower, GA 30905-5300.

SUMMARY OF DUTIES:

1. The Network Communication Systems Specialist supervises, installs, operates and performs limited field level maintenance on commercial and tactical fiber, cabling and wiring, IP based high speed electronic nodal systems, integrated network control centers, network management facilities, associated multiplexing and subscriber interface equipment, multichannel line-of-site systems and associated relays, tropospheric scatter communications systems, tactical terrestrial satellite communication systems, anti-jam reliable tactical terminals, communications security (COMSEC) devices, and associated equipment Performs network management functions in support of maintaining, troubleshooting, and reengineering of associated network assets in support of operational requirements. Installs, operates, perform strapping/re-strapping, Preventive Maintenance Checks and Services (PMCS), and field level maintenance on COMSEC devices. Operates and performs PMCS on assigned vehicles, power generators and equipment.

2. Plans, coordinates, and supervises installation, operation, maintenance, and management of network communication systems, including radio, tactical satellite terminals, switching, cable, and automation equipment. Supervises the installation, operation, strapping, re-strapping, preventive maintenance checks and field level maintenance on COMSEC devices. Directs restoration, and alternate routing of circuits, trunks, links, and systems. Develops and implements field level signal maintenance programs. Provides operational and technical assistance to subordinates and commanders. Verifies frequency operational requirements, network communication systems service requests, and disseminates operations information to ensure command and control communications connectivity. Requests and ensures appropriate logistical support is available at all times. Assimilates and reports system/network statistics. Develops and implements training programs for Signal personnel. Uses computers to process operational and administrative information. Operates system control facilities as part of Signal organization management functions.
